MEMORANDUM OF UNDERSTANDING

between

SLOBOMIR P UNIVERSITY

And

CITY UNITY COLLEGE

1. SCOPE

SLOBOMIR P UNIVERSITY and City Unity College Athens Greece, hereby agree to explore opportunities for academic collaboration to their mutual benefit.

Nothing in this Memorandum of Understanding shall be construed as creating a legal relationship between the two parties.

2. PROPOSED DEVELOPMENTS

Both institutions intend to develop academic collaborations on the following:

- a) College City U Educational Ltd will act as a center for recruiting students to SLOBOMIR P UNIVERSITY and vice versa.
- b) College City U Educational Ltd will act as a center for the delivery of Distance Learning Awards delivered by SLOBOMIR P UNIVERSITY. The degrees/Diploma/Master will be awarded from City University of Seattle through Distance learning framework.
- c) Arrangements for progression of suitably qualified students from some of College City U Educational Ltd's courses to equivalent degrees at SLOBOMIR P UNIVERSITY.
- d) Collaborative arrangements between SLOBOMIR P UNIVERSITY and College City U Educational Ltd for awards and/or parts of awards for delivery in Greece by College City U Educational Ltd.
- e) Exchange of faculty staff: for the purposes of staff development, planning and handling of academic programmes, organization of seminars and conferences, including the sharing of mutual experiences in teaching, research and industrial practice.
- f) Discussion of other areas of mutual interest.

A timetable for progressing developments will be agreed between the two institutions.

The proposed developments will be subject to the relevant quality assurance arrangements of both SLOBOMIR P UNIVERSITY and College City U Educational Ltd.

3. FINANCE ARRANGEMENTS

The cost of undertaking the initial developments indicated above will be shared between SLOBOMIR P UNIVERSITY and College City U Educational Ltd.

4. PUBLICITY

Because this Memorandum of Understanding does not constitute a legal relationship between the parties, no advertising or publicity relating to it will be permitted without the express prior agreement of both parties. Publicity and advertising of the relationship will be permitted following the validation and approval of specific academic collaborative arrangements, subject to the prior approval of the relevant authorities at each party.

5. DURATION OF THE MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding is initially valid for three years from the date of signature. At the end of the three year period it will be considered for renewal.

This Memorandum of Understanding will be reviewed annually and may be terminated by either party by written notice.

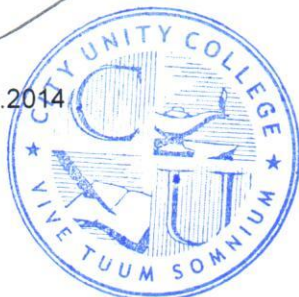
