OF AFFIRMATIVE MEASURES FOR THE ENROLMENT OF CANDIDATES WITH MALIGNANT DISEASES AND DISABILITIES

Pursuant to Article 54(4) of the Law on Higher Education ("Official Gazette of the Republic of Srpska," Nos. 67/20 and 107/24) and Article 26 of the Statute of Slobomir P University, the University Senate, at its 4th session held on 09/23/2025, hereby adopts the

PROGRAM

OF AFFIRMATIVE MEASURES FOR THE ENROLMENT OF CANDIDATES WITH MALIGNANT DISEASES AND DISABILITIES

I GENERAL PROVISIONS

Article 1

This Program of Affirmative Measures for the enrolment of candidates with malignant diseases and disabilities is adopted in accordance with Article 67(4) of the Law on Higher Education of the Republic of Srpska ("Official Gazette of the Republic of Srpska," Nos. 67/20 and 107/24).

Article 2

This Program prescribes the conditions of enrolment, ranking, and other related matters for candidates with malignant diseases and disabilities.

II. INITIATION OF PROCEEDINGS

Article 3

Persons with disabilities and malignant diseases are required to submit, in addition to the application documentation, the following:

- Request for Determination of Enrollment Eligibility;
- Medical documentation evidencing the existence of physical impairment or disease (not older than six months) issued by a competent healthcare institution;
- Recommendation from a psychologist or pedagogue, if applicable;
- Additional documentation that may be requested from the candidate during the decision-making process.

All documentation submitted for the purpose of enrollment shall be considered confidential and shall be maintained in the University archives.

III. ENROLLMENT OF CANDIDATES

Article 4

The Rector of the University shall decide on the approval of enrollment based on the report of a three-member Commission composed of faculty members at the University. Once the right to enrollment has been determined in accordance with the general acts and pursuant to the Programme, it shall remain valid for the entire duration of studies at the University, unless medical findings or other appropriate documentation indicate otherwise.

Article 5

Under the Programme, candidates with malignant diseases or disabilities may be enrolled as full-time students, part-time students, or foreign nationals.

Article 6

Candidates with malignant diseases or disabilities shall take the entrance examination if such is required for enrollment in a particular study programme, whereby the examination shall be administered in a manner adapted to their capabilities. The programme and content of the entrance examination may not be modified and shall be the same for all candidates applying for admission to studies.

Article 7

Candidates with malignant diseases and disabilities shall be ranked on separate ranking lists. According to their rank on those lists, they shall be incorporated into the ranking lists of all candidates for enrollment in the study programme.

IV. FINAL PROVISIONS

Article 8

The Programme shall be applied commencing with the enrollment of students in the first year of the first or second cycle of studies in the academic year 2025/2026.

Article 9

This Programme shall enter into force on the date of its adoption and shall be published on the University website.
